#### Article 5

Rev. David Den Haan works through the report of the Transition Team. He invites several persons to assist him in his report. Some of those who contribute are: Rev. Tim Holwerda, Rev. Terry Genzink, Rev. Matt Paslrok, Rev. Bob Huisman and Kraig Rotman. Much very encouraging discussion is generated by this report.

# Article 6

Rev. Josh Van Drunen offers a prayer for the work of the Transition Team.

#### Article 7

Rev. Tim Holwerda reports for the Student Fund Committee. He shares some of the current realities of the committee's work and shares that it is currently passing through a period of transition. This is received for information. It is also reported that Rev. Steve Hasper's term on the Student Fund Committitee is done and that a replacement needs to be selected. The names proposed for this position are: Rev. Robert Huisman, Rev. David Jolman and Rev. Matt Palsrok. A motion is made to move the selection of this person to our May 2013 meeting. The motion finds support and carries. Rev. Steve Hasper agrees to stay on the Committee until the decision is made in May.

#### Article 8

The Council of the Messiah Church presents a motion to approve the retirement of Rev. Terry Genzink on June 15, 2013. The motion finds support and carries.

Because Rev. Terry Genzink is retiring in June of this year, his position as Regional Pastor needs another person to be appointed.

Special acknowledgement of the work and contribution Rev. Genzink has made to Classis as Regional Pastor is made. His leadership and caring manner are recognized. A prayer of thanks for Rev. Genzink is offered by Rev. Josh Van Drunen. A song is sung at this time accompanied by Rev. Van Drunen.

#### Article 9

Rev. Gerry Koning has asked to be replaced as the Synodical Deputy for Classis Georgetown. He has finished one term and is unable to serve another term. Rev. Matt Palsrok, who is currently serving as alternate, is appointed as Deputy and Rev. Mark Bennink as appointed as Alternate Synodical Deputy. This is approved by motion made, supported and passed.

A prayer is offered to bless the work of the committees of Classis and to be a blessing to the new people taking the place of those leaving office. This followed by the singing of a song - "They will know we are Christians by our Love."

#### Article 10

First Jenison Christian Reformed Church reports that they have contacted the Pastoral Church Relations Committee of the denomination for assistance in their future procedural steps. This is received for information.

#### Article 11

The Treasurer's Report was presented. It was reported that our funds all currently have positive balances. This is received for information.

The report is followed by those in attendance joining in the prayer of St. Francis of Assisi

#### Article 12

The Credentials Committee presents their report. The major consideration on the credentials for this meeting is the request from Evergreen Ministries that Classis Georgetown approve the request from Searchlight Ministries that they be allowed to organize as a church in the classis and denomination. This comes as a motion to Classis. After much discussion the motion is approved.

Rev. Steven Hasper offers a prayer for the church at Searchlight Ministries.

#### Article 13

The Clerk of Classis distributes a number of notices that have been received since the agenda for this meeting was distributed. The denominational committee caring for the archives of each church advises that several pieces of information and history are missing from the churches of Classis Georgetown. A sheet is passed to the delegates so that each church can review the items missing from their church and take appropriate action.

The clerk distributes a ballot with the names of pastors and elders who are eligible to be delegates to the Synod of 2013. The group is asked if there are other names that could be added. When this procedure is complete he asks the delegates to vote for the nominees of their choice. The following is the result of the balloting:
