II. WELCOME AND WORSHIP

Article 3

A. Opening worship, Rev. Kuyvenhoven:

- 1. After Rev. Kuyvenhoven welcomes all present, he turns the meeting over to projected. (See attached compilation)
 - a. "Shine on Us"
 - b. "Majesty"

- 2. Rev. Nate Meldrim reads Matthew 25:31-46, with the gathering invited to join in on vv. 40 and 45.
- 3. This is followed by a prayer song, "Here I Am, Lord."
- 4. As President Kuyvenhoven leads in a meditation on Luke 10:25-37, the parable
- 5. After a time of reflection and commitment, the delegates are led in a discussion
- 6. Rev. Kuyvenhoven then leads the group in prayers asking God to lead us into risky compassion.
- 7. Our worship time is closed by singing a song of commitment, "Lord, Speak to Me That I May Speak," swapping plural pronouns for all singular pronouns.

III. WE WORK TOGETHER TO DO THE BUSINESS OF CLASSIS

Article 4

A. Welcome

1. Rev. Kuyvenhoven welcomes all delegates and acknowledges the visitors; Dr. Erik Carter, from Vanderbilt University, our special guest for the evening; Ms. Laura Keeley from Faith Formation Ministries; Ms. Dee Obrecht, Criminal Justice Chaplaincy; and Ms. Pam Steenstra, Georgetown Harmony Homes.

B. Overture to Synod from Forest Grove CRC

- 1. Background: this past November the congregations of the CRCNA were given three substantial and substantive reports for study purposes. Due to the timing of the reports, the serious nature of the materials, and the size of the reports, not enough time is provided to do justice to a thorough study and to report back to Classis and then Synod.
- Motion: The council of Forest Grove CRC overtures Classis Georgetown to overture Synod to instruct future study committees to provide, on the day that a study committee report is made available for councils, a 1-2 page summary of that report, (recommendations may be left out).
 Motion was made, seconded, and carried.

3. Grounds:

- a. Local councils should be encouraged to become aware of and involved in denominational matters. This is the church doing its work as one body.
- The study committee is in the best position to offer an accurate, accessible summary of its report so as to facilitate local council involvement.

C. First Jenison's motion:

- The following motion was presented by the council of First Jenison CRC:
 The council of First Jenison Christian Reformed Church seeks the approval
 of Classis Georgetown on the decision of First Jenison Christian Reformed
 Church to disband. The effective date to disband will be July 11, 2016.
 Motion was MSC. By mutual consent of both councils, the remaining
 memberships at First Jenison are transferred to Baldwin Street CRC so that
 there is no gap in spiritual care.
- 2. President Kuyvenhoven led the delegates in a brief slideshow presentation regarding the history of First Jenison CRC.

- 3. Rev. Adam Barton, pastor of First Jenison, thanked Rev. Brian Bosscher for being a wise advisor, and Rev. Joel Boot, for his partnership in the closing process.
- 4. President Kuyvenhoven prayed for this church, as she lived out the role of giving from the mother church, and because of this, daughter churches are growing.

D. Retirements:

- 1. Motion: The council of the Ridgewood Christian Reformed Church requests Classis Georgetown to grant Rev. Jim Molenbeek emeritation effective June 30, 2015 for reason of age. Motion was MSC.
- 2. Please note corrected minute of September 17, 2015: Rev. Molenbeek's request was to have his membership transferred, and not his credentials. This was acted on at the July 21, 2015 meeting of the Ridgewood council.
- 3. Motion: The council of Baldwin Street has asked Classis Georgetown to June 30, 2016, for reason of age. Motion was MSC. Rev. Mark Bennink was asked to serve as counselor to Baldwin Street during this vacancy.
- 4. Rev. Van Groningen addressed the delegates. He gave gratitude to God for the privilege of working in Classis Georgetown, and among other churches.
- 5. Rev. Mark Bennink closed this section of our meeting with prayer for the retiring pastors.

V. HELPING PEOPLE WITH DISABILITIES FIND EMPLOYMENT

Article 5

- A. Presentation by Dr. Eric Carter, who is connected with the Kessler Foundation in Atlanta.
 - 1. He provided many current statistics about disabled people and employment.
 - 2. The focus of his work is Putting Faith To Work by enabling faith communities to address the employment needs of their disabled members.
 - 3. This is a critical need in our society as the unemployment rate of people with disabilities is nearly 80% and those with disabilities share the same aspirations as those without them.
 - 4. This was followed by a short time of questions.
- B. Presentation by Rev. Koning about LLC's.
 - 1. He and his wife have 2 children with disabilities, for whom they have created
 - 2. Their daughter packages and sells bird seed for her business and their son has contracted to clean the playground equipment weekly in Grandville.
 - 3. LLC's take some time to set up, but are well worth the time and energy.
