Article 4

A. Introduction of Candidate Cody Zuiderveen, Rev. Brian Bosscher

Rev. Bosscher introduces Cody. Cody is a child of Hillcrest CRC, where he was nurtured and discipled in his faith. He received his undergraduate degree from GVSU, his M. Div from Gordon-Conwell Theological Seminary, and his ThM in Systematic Theology at Calvin Seminary. He also completed the requirements of Ecclesiastical Program for Ministerial Candidacy at Calvin Seminary. Cody and his wife, Jessica, will serve as missionaries with CRWM in Port-au-Prince, Haiti.

Rev. Bosscher led a prayer for guidance of the Holy Spirit throughout the exam.

B. Proper procedure:

- 1. Rev. Tim Holwerda conducted the practical exam. This was followed by a motion to proceed which was MSC.
- 2. Rev. Brian Bosscher (in concurrence with Rev. Terry Genzink) reported favorably on the sermon that was preached on October 30, 2016, at Hillcrest CRC. **Motion was MSC to proceed. The Synodical Deputies concurred with this decision.**
- 3. Rev. David DenHaan presided over the theological exam. **Motion was** made to accept Candidate Zuiderveen into the ministry of the Word and Sacraments in the Christian Reformed Church.
- 4. Executive session is declared (visitors are excused).
- 5. The Synodical Deputies are excused to conduct their deliberations.
- 6. Motion is to be voted on by paper ballot. After a brief discussion, ballots are counted, Motion was seconded and carried to accept Candidate Cody Zuiderveen into the ministry of the Word and Sacraments in the Christian Reformed Church. The Synodical Deputies gave their concurrence to classis' decision.
