#### 12-4: Review of grants:

- **A.** Gerry reported on three grants:
  - Celebration Fellowship CRC is doing well and hopes to plant a church in a women's prison.
  - 2. Georgetown Harmony Homes is doing well in dealing with serious cuts in finances because of government cuts, but is still hoping to build another home.
  - 3. The Youth for Christ grant was originally to supplement Rev. Marv Vander Vliet's salary, but he has retired and is now working as a volunteer, so this grant may need to be reconsidered.

  - 2. Criminal Justice Chaplaincy is working on their mentoring, adding more mentors and more training.

# 12-7: Financial report, Mel reporting:

The letter will be signed by the voting members of the Vision Team.
