Rev. Arthur J. Van Wolde is the single nominee for this position. He serves as senior pastor of Haven CRC in Zeeland, Michigan. He has served there since 2012 and has previously served churches in Dearborn, Michigan; Bunde, Minnesota; and Pella, Iowa. He received training from Kuyper College and Calvin Theological Seminary. He has served as a member of the board of trustees of Kuyper College, the launch team for New Life Prison Congregation (Newton, Iowa), and the classis interim committee of Classis Central Plans. He is currently serving on the classis interim team for Classis Zeeland.

c) Request from Fairway CRC:

The Council of Fairway CRC, with the endorsement of the CRC Candidacy Committee, seeks approval that Mr. Jeremy Rhodes be allowed to enter the CRC ministry through Church Order Article 8 rather than through the Article 6 candidacy process. The learning plan known as the MEPMC, involving accredited work at Calvin Theological Seminary, would still be required.

CRCNA Church Order Article 8-c:

Ministers ordained outside of the CRCNA who desire to become ministers in the Christian Reformed Church shall be required to complete a learning plan endorsed by the Candidacy Committee

Motion: That Classis Georgetown approve an adjustment to the ordination affiliation process of Jeremy Rhodes, making use of Church Order Article 8 rather than the candidacy route of Church Order Article 6.

Grounds:

- 1. As the candidacy committee received more information about Jeremy's training and experience in ministry, they suggested that this change would be appropriate.
- 2. Jeremy would still have an accredited learning plan in the matters that are required for a thorough orientation to CRCNA ministry.
- 3. The step of Commissioned Pastor examination would still serve as a helpful tool for the affiliation process and for getting acquainted with Jeremy.
